¹ The value of a basic consumption basket is calculated on the basis:

- 1) the minimum foodstuffs set approved by the Ministry of Health;
- 2) the relative weight of food and non-alcoholic beverages (Engel coefficient) in actual weight in the structure of monetary consumption expenditure of Lithuanian residents, calculated on the basis of the newest available household budget surveys of the Department of Statistics;
- 3) average retail food prices published by the Lithuanian Department of Statistics

For 2018, the value of a basic consumption basket is: EUR 238 for single person, EUR 500 for two adult and two children under 14
